Local News

Namibia's FATF Progress

Namibia has made notable progress in addressing anti-money laundering (AML) and counter-terrorism financing (CTF) deficiencies, having resolved 8 out of 13 items on its FATF Action Plan since being grey-listed in February 2024. The Financial Intelligence Centre (FIC) submitted a second progress report, and the FATF commended the country's efforts.

However, five key issues remain, including:



Despite this progress, the European Union added Namibia to its high-risk list on 10 June 2025, prompting increased scrutiny and compliance requirements for financial transactions involving Namibian entities in the EU. The FIC remains committed to full remediation and continues to work with international partners to restore Namibia's financial standing.

BIPA Extends Penalty Waiver Programme for Annual Duties Until 30 September 2025

The Business and Intellectual Property Authority (BIPA) has officially extended the deadline for its Annual Duty Penalty Waiver Programme to 30 September 2025. This initiative is aimed at helping registered businesses bring their records up to date by waiving 100% of penalties and late submission fees incurred between 2012 and 2022.



Who qualifies?

The programme applies to Companies, Close Corporations, and Section 21 entities that:



Why this matters:

BIPA's Acting CEO, Ainna Kaundu, emphasised that the extension supports SMEs and other struggling businesses, helping them remain active contributors to Namibia's formal economy. Entities are encouraged to act promptly and make use of this limited-time relief window.

BIPA Begins Deregistration of Non-Compliant Entities

The Business and Intellectual Property Authority (BIPA) has commenced the **deregistration process of thousands of business entities** that have failed to comply with mandatory disclosure requirements – particularly relating to **Beneficial Ownership (BO) information**.

Under the Business and Intellectual Property Authority Act and related regulations, all registered entities in Namibia are required to disclose and regularly update information on their ultimate beneficial owners. This forms part of the country's broader efforts to improve corporate transparency, combat financial crimes, and align with international anti-money laundering standards.

Key implications:

Lose Legal Standing

Deregistered entities lose legal standing, making it unlawful to continue trading under that business name.

Restriction of Services

Banks and regulators may restrict services to noncompliant or deregistered entities.

Reinstatement requirements

Reinstatement requires full BO disclosure and settlement of outstanding fees or penalties.

BIPA has urged all business owners to ensure their entity details are up to date and compliant, emphasising that maintaining transparency is now non-negotiable for doing business in Namibia.


Mental Health


Winter Nights




